

HC adjourns move against CM

The Gauhati High Court on Tuesday adjourned the move to register cases against Chief Minister and revenue minister in connection with the Pranab Boro self immolation case.

The high court intervention came after the court heard a petition of the government challenging the additional chief judicial magistrate's order to file a case against the duo acting on the complaint of the victim's wife.

The court, however, has issued notice to the ACJM in Kmarup in this regard and decided to hear the entire case after the bihu.

Notably, ACJM has directed Dispur police to file case against chief minister Tarun Gogoi and revenue minister Pritivi Majhi on the basis of Purnima Boro's allegation that the duo were responsible for the self immolation of his husband in Dispur on February 24.

KOKRAJHAR, September 22, 2026 — The All Bodo Students' Union (ABSU) on Tuesday burnt copies of a book titled *Hamkoshar Parishista* during protests held at several locations across Assam, including Gauhati University, objecting to what it described as the use of the Assamese script to represent the Bodo language.

Hamkoshar Parishista is a multilingual appendix containing learning resources for indigenous languages of Assam, including Bodo, Rabha, Mising and Karbi.

During the protests, ABSU members alleged that Bodo has been represented in the publication using the Assamese script instead of Devanagari, the script used for Bodo.

The organisation asserted that Bodo is recognised under the Eighth Schedule of the Constitution of India and is an Associate Official Language of Assam. ABSU demanded that Bodo be represented in its recognised script in educational and learning resources.

ABSU president Khwrmmdao Wary said the use of the Assamese script to represent Bodo in the publication was disrespectful to the Bodo language and literature.

He said Bodo is an Associate Official Language of Assam and a language recognised under the Eighth Schedule of the Constitution.

Wary demanded the immediate withdrawal of the publication in its present form and called for the use of the Devanagari script for Bodo in the book.
