Perused the preliminary enquiry report submitted by Director No. AAP.19/2015/23 General of Vigilance & Anti Corruption, Assam into the allegations of serious anomalies in the camps set up in Gossaigaon Sub-division of Kokrajhar District in the aftermath of violence in December, 2014.

It is reported that the number of inmates of the relief camps were shown to be higher than the actual number of inmates, which resulted in issue of much higher quantities of relief materials to the camps than it was actually required. It is reported that there has been misuse of Government money with a view to misappropriate Government fund by indulging corrupt and dishonest practices.

Shri Amalendu Roy, ACS, SDO (Civil) Gossaigaon was responsible for the administration of relief camps and distribution of relief materials etc. in Gossaigaon Sub Division. On the basis of preliminary enquiry report, it is decided to draw up Departmental Proceedings against Shri Amalendu Roy, ACS, SDO (Civil), Gossaigaon.

It has also been decided to conduct a regular enquiry by the Director General of Vigilance & Anti Corruption, Assam.

Further, with a view to ensure smooth conduct of regular enquiry and pending drawal of departmental proceeding, Shri Amalendu Roy, ACS, Sub-divisional Officer (Civil), Gossaigaon is placed under suspension under Rule 6(1) of the Assam Services (Discipline & Appeal) Rules, 1964 with immediate effect.
